具体操作流程如下:

## 1. 申请流程

- 1) 客户需在国内提出书面申请,随申请提交经发货人及订舱代理共同签章的担保函(保函格式如附件); 担保函须包含以下保证内容:为收货人提供的银行保函提供连带责任担保; 担保可能产生的滞箱费等相关费用的支付。
- 2) 我司在收到完整申请材料并审核通过后,将通知吉布提代理接受银行保函办理提箱手续,客户可直接联系我司目的港代理办理。

## 三、注意事项

- 1. 保函格式需符合我司标准要求
- 2. 申请材料需在货物目的港未提箱前
- 3. 具体金额标准请咨询当地代理

# Notice on the Operation of Container Deposit Fees at the Port of Djibouti

Date: July 14, 2025

#### Dear Valued Customers,

To ensure the security of our container assets and address customer needs, we hereby provide the following details regarding container deposit fees at the port of Djibouti:

# I. Operational Background

In accordance with Djibouti port practices, local agents will collect a cash container deposit fee upon container release, based on market standards.

#### II. Alternative Solution

To offer a more flexible settlement method and meet customer demands, we now accept a **bank guarantee** issued by a local Djibouti bank as an alternative to the cash deposit.

# **Application Process**

The customer must submit a written application domestically, along with a guarantee letter jointly signed by the shipper and the booking agent (see attached template).

Upon approval of the complete application materials, we will notify our Djibouti agent to accept the bank guarantee for container release. Customers may then proceed with the process by contacting our destination agent directly.

## **III. Important Notes**

The guarantee letter must comply with our standard format.

Application materials must be submitted **before** the cargo is picked up at the destination port.

For specific fee standards, please consult the local agent.
